<p>1. How has the organisation/project had an impact on and celebrated the lives of the LGBTIQA+ community in Melbourne?</p> <p><i>20 points</i></p>	<ul style="list-style-type: none"> <li>• What is the objective of the project or motivation behind the contribution?</li> <li>• Include information on the organisation/project's duration.</li> <li>• Detail the specifics of the benefit made to Melbourne's LGBTIQA+ community.</li> <li>• Describe how the organisation/project is unique to Melbourne or innovative in any way.</li> </ul>

<p>2. Demonstrate how the organisation/project has enhanced the lives of community members.</p> <p><i>20 points</i></p>	<ul style="list-style-type: none"> <li>• Outline partnerships or networks that have been formed. What degree of impact will they have on the project? Will they be maintained?</li> <li>• Outline the level of support that has been acquired from external bodies.</li> <li>• Who has benefitted from these changes?</li> <li>• Outline any community or stakeholder consultation that has been undertaken.</li> </ul>
<p>3. Has the organisation/project achieved a successful outcome and a positive effect on the Melbourne community? How has this success been measured?</p> <p><i>20 points</i></p>	<ul style="list-style-type: none"> <li>• Provide anecdotal evidence or documentation of results</li> <li>• Outline how the organisation/project has been received by the community</li> <li>• Describe if the organisation/project has achieved outcomes beyond what was expected</li> </ul>
<p>4. Describe any challenges that were faced during the implementation or delivery of the organisation/project. How were they overcome?</p> <p><i>20 points</i></p>	<ul style="list-style-type: none"> <li>• Outline the obstacles that were encountered or any issues faced in the day-to-day running of the organisation/project.</li> <li>• Detail the steps taken to overcome these challenges, and any plans in place to avoid these occurring in the future.</li> </ul>
<p>5. What will be the long-term impact of the organisation/project?</p> <p><i>20 points</i></p>	<ul style="list-style-type: none"> <li>• Outline long-term planning, succession planning and the vision for the future.</li> <li>• Identify any long-term benefits to the Melbourne community.</li> <li>• Describe how these benefits can be transferred elsewhere and/or on a wider scale.</li> <li>• Describe how partnerships developed can be used in the future.</li> </ul>
