1.2. an instrument of sub-delegation 2024-22 dated 26 March 2024

1.3. all other powers held by or delegated to me,

and having taken into account the local law requirements of the Council pursuant to the *Local Government Act 2020*

2. the form of the Notice to Comply pursuant to clause 5.10 of Part 5 of the Local Law is generally in the form annexed.

3. for the avoidance of doubt, the form of the Notice to Comply may vary from the form attached, provided that it complies with the requirements of clauses 5.11 and 5.12 and 5.13 of the Local Law and does one or more of the things specified in clause 5.13(a) – (e) inclusive of the Local Law.
