### Purpose and background

- 1. The purpose of this report is to recommend that as a result of the Coronavirus (COVID-19) pandemic Council allocate \$200,000 from unspent funds in the 2019-2020 budget towards a Coronavirus Response Community Grants Program.
- 2. The Community Use of Town Hall Sponsorship (CUTHS) program cannot continue to financially support organisations to hold events in Melbourne Town Hall or Meat Market, North Melbourne during the pandemic. All successful grant recipients and those who have applied have been informed that the program has been suspended and the matter will be revisited in the new financial year.
- 3. This leaves \$175,000 of unspent funds in the CUTHS program. This amount together with \$25,000 from the Community Services branch operational budget would provide a Coronavirus Response Community Grants program to support not-for-profit organisations and community groups to assist local communities.
- 4. A broad range of community organisations and management have shared concerns that vulnerable community members may be at heightened risk of hardship as a result of COVID-19. Some community members are also withdrawing from contact with essential support services resulting in increased loneliness and isolation. Social distancing requirements and a lack for some, of connection to publically accessible WiFi is affecting others. There are also those who are choosing to ignore distancing requirements putting others at risk.

## Key issues

- 5. It is proposed that grants of up to \$5,000 can be used for the purchase and distribution of essential food supplies and material aid as well as to encourage innovative ways to reduce social isolation and build community connection while reinforcing the importance of social distancing.
- 6. In exceptional circumstances, including where an organisation is able to demonstrate having spent their grant received and more funds are required, greater than \$5,000 could be allocated.
- 7. Requests for grants will be considered by Council Officers if an organisation or community group meets the following criteria:
  - 7.1. Located within the City of Melbourne or provides services within the municipality.
  - 7.2. Directs support to residents of the City of Melbourne.
  - 7.3. A not-for-profit organisation or recognised community group with proven engagement with high need individuals and vulnerable communities.
  - 7.4. An organisation that does not have pre-existing debt or non-compliance issues with any grant, contract, or tender with the City of Melbourne.
  - 7.5. Has an ABN.
- 8. Councillor Beverley Pinder and Councillor Jackie Watts as Chair and Deputy Chair, respectively of the People City Portfolio will provide strategic input prior to Council Officers assessing applications.

# **Recommendation from management**

9. That Council allocates \$200,000 from its 2019-20 budget to establish a Coronavirus Response Community Grants program in response to the declared coronavirus (COVID-19) pandemic to support not-for-profit organisations and community groups to assist local communities.

It is however feedback from community groups and individuals of the hardship being experienced during this coronavirus pandemic that has had officers initiate the recommendation to Council. The grants program will be socialised on the City of Melbourne website and via Council's extensive networks across the community sector.
