# Purpose and background

1. The purpose of this report is to consider the dates, times and venues for meetings of the Council and its Future Melbourne Committee (FMC) for 2021.

## Key issues

- 2. Typically FMC meetings are scheduled on the first and third Tuesdays of the month and Council meetings are scheduled on the last Tuesday of the month.
- 3. The schedule (refer Attachment 2) should be approved at the 15 December 2020 Council meeting, to allow for ratification of the meeting dates by the FMC on 2 February 2021.
- 4. Public notice of the meeting dates will be provided on Councils website.
- 5. The schedule can be amended by resolution of the Council as necessary.
- 6. Next year's National General Assembly of Local Government is to be held from 20 to 23 June 2021, which will not affect the scheduling of the June FMC meetings (1 June and 15 June 2021).
- 7. Due to the:
  - 7.1. Easter public holidays, FMC meetings will be held on the second and third Tuesday in April 2021.
  - 7.2. Melbourne Cup public holiday, FMC meetings will be held on the second and third Tuesday in November 2021.
