# Councillor representation on the Northern Alliance for Greenhouse Action Executive Board

# Purpose and background

- 1. This report seeks endorsement for Councillor Elizabeth Doidge to be Council's representative on the Northern Alliance for Greenhouse Action (NAGA) Executive.
- 2. City of Melbourne has been a member of NAGA since 2002, a group consisting of nine councils in Melbourne's inner north to coordinate and collaborate on climate action. The member councils are the Cities of Banyule, Darebin, Hume, Manningham, Melbourne, Nillumbik, Moreland, Whittlesea and Yarra.
- 3. NAGA facilitates information sharing amongst member councils, identifies and supports delivery of cross council projects on climate action and advocates on behalf of its members to help create a zero carbon economy.
- 4. As a member of NAGA, City of Melbourne has the opportunity to nominate a councillor representative (alongside a management representative) to the NAGA Executive.

# **Key issues**

- 5. The role of NAGA's Executive is to ensure sound and effective decision-making; incorporate processes for accountability to the alliance as an entity, to individual alliance member councils; and maintain effective communication and information exchange within NAGA's network. The full Terms of Reference are included in Attachment 2.
- 6. The NAGA Executive has representation from councillors across the membership, however to date management has represented City of Melbourne on the NAGA Executive.
- 7. As Deputy Chair of the Environment Portfolio Councillor Elizabeth Doidge is ideally placed to represent City of Melbourne on the NAGA Executive and has expressed an interest in participating.
- 8. Management will continue to attend NAGA Executive meetings to support the Councillor.

# **Recommendation from management**

9. That the Future Melbourne Committee nominate Cr Doidge to the Northern Alliance for Greenhouse Action Executive.

#### Attachment 2 - NAGA Executive Terms of Reference

#### **NAGA Governance Terms of Reference 2020**

#### Introduction

The Northern Alliance for Greenhouse Action (NAGA) formed in 2002. NAGA's members are the Cities of Banyule, Darebin, Hume, Manningham, Melbourne, Moreland, Whittlesea, Yarra and Nillumbik Shire Council.


NAGA's goal is to substantially contribute to the transition to a zero-carbon future by sharing information, delivering effective programs and leveraging local government, community and business action. NAGA implements climate change action projects, and undertakes research into emissions reductions, and impacts and adaptation across the NAGA region. NAGA members also establish their own cutting-edge projects, which can act as pilots for future NAGA projects.

NAGA's Executive was formed in 2009 to ensure sound and effective decision-making; incorporate processes for accountability to the alliance as an entity, to individual alliance member councils; and maintain effective communication and information exchange within NAGA's network. As part of this process, the Terms of Reference for NAGA's Executive were developed.

Hume City Council fulfils a 'lead role' for NAGA membership and governance, through the NAGA Memorandum of Understanding between Hume City Council and each of the other NAGA member councils. As part of this role, Hume City Council receives NAGA member councils' membership contributions, and employs the NAGA secretariat.

In 2012, NAGA formed the Implementation Forum, to replace the NAGA Steering Committee and NAGA Network. As part of this process, NAGA's governance structures were reviewed and the revised structures adopted. These are represented, and their membership, functions and meeting frequency summarised on the following page.

#### **NAGA** Executive

The Northern Alliance for Greenhouse Action (NAGA) Executive Terms of Reference should be read in conjunction with the NAGA Memorandum of Understanding. These Terms of Reference aim to ensure appropriate governance and decision-making.

#### Terms of Reference

- 1. To establish the strategic directions for NAGA's priorities, actions and operations.
- 2. To establish, manage and monitor NAGA's Finance Strategy, including identifying funding for NAGA's coordination and project implementation roles, and approving the annual budget.
- 3. To ensure high level members' engagement with NAGA's strategic directions.
- 4. To identify advocacy issues and authorise advocacy submissions.
- 5. To recommend to Hume City Council changes to the terms of reference.

# Composition of NAGA Executive

One representative (Councillor or senior staff) from each of the NAGA Council members. Council staff can attend/accompany Councillors as observers or substitutes.

#### Meetings

Quarterly, with at least three meetings held each year. Minutes will be taken by NAGA Secretariat.

#### Implementation Forum

The NAGA Implementation Forum Terms of Reference should be read in conjunction with the NAGA Executive Terms of Reference and the NAGA Memorandum of Understanding. These Terms of Reference aim to ensure appropriate governance and decision-making.

### Terms of Reference

- 1. To share information and identify opportunities for collaborative approaches to climate change actions and responses.
- 2. To establish and contribute to implementation of NAGA projects, consistent with the strategic directions and priorities established by the NAGA Executive.
- 3. To identify issues, barriers and opportunities in project implementation, and refer these to NAGA Executive.

# Composition

Up to 2 representatives (coordinator and/or officers) nominated by each of the NAGA members (one of the 2 nominated members may be from an associated organisation such as an associated energy or sustainability foundation).

## Meetings

Meetings will be held on an as-needs basis rotated between the NAGA member councils. The Implementation Forum will aim to hold two meetings per year.

Meetings will be chaired by the host council. Minutes will be taken by NAGA secretariat.
