Future Melbourne Committee Meetings in Neighbourhood Locations in 2021

Purpose and background

1. The purpose of this report is to support Future Melbourne Committee (FMC) meetings that are held on the third Tuesday of each month to be held in community locations, starting at 6pm.

Key issues

- 2. Council adopted the schedule of Council and Future Melbourne Committee meetings for 2021 at its meeting on 15 December 2020, including the venue for meetings, being the Town Hall Administration Building.
- 3. It is proposed to hold FMC meetings that are scheduled on the third Tuesday for the months of September, October and November 2021 at neighbourhood locations.
- 4. These FMC meetings are to be held in neighbourhood locations to provide the community with an opportunity to meet Councillors and better understand, participate in, experience and engage in Future Melbourne Community meetings, through attending, observing, making a submission and/or asking a public question in a local neighbourhood setting.
- 5. It is also proposed to amend the start time of these FMC meetings to 6pm, to allow for the community and Councillors to engage and discuss matters informally prior to the FMC meeting.
- 6. In accordance with the Council's Governance Rules, the meeting schedule can be amended by resolution of the Council, in order to facilitate the arrangements for meetings to be held at various locations.

Recommendation from management

- 7. That Council:
 - 7.1. Approves the revised start times for the third Tuesday Future Melbourne Committee (FMC) meetings for the months of September, October and November 2021, as detailed in Attachment 2 to the management report.
 - 7.2. Authorises the Chief Executive Officer, in consultation with the Lord Mayor, to determine the venue for the community FMC meetings to be held in September, October and November 2021 and that the community receive at least three weeks' notice of the venue.
